THE ULTRA-MITT BASEBALL GIVEAWAY
CONTEST RULES

These rules apply to the Ultra-Mitt Baseball Giveaway contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WBQT (“Station”). **In addition, the General Contest Rules posted at www.hot969boston.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Tuesday, April 9, 2019 and end on Monday, April 15, 2019.
- b. To participate in the Contest, entrant may enter online and on-site as follows:
- c. To enter online, visit www.hot969boston.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on April 9, 2019 at **12:01am** Eastern Time (“ET”) and ending on April 15, 2019 at 11:59pm ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- d. To enter on-site, visit a Station appearance in the Boston Metro Area beginning on April 9, 2019 and ending April 15, 2019 to obtain an official entry form (available while supplies last). Specific dates, times, and locations for each appearance will be announced on-air and posted online All entry forms must be filled out completely and legibly and submitted as instructed by the Station. Incomplete or illegible entries may be removed in the Station’s sole discretion. Entries must be received by the end time of each appearance as disclosed by the Station. **One (1) entry per person per appearance.**
- e. There will be up to a total of one (1) winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Massachusetts and New Hampshire, except where prohibited by law. Entrants must possess a valid, government-issued ID and must show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) grand prize will be awarded. Grand prize consists of a Calusa Marketing voucher to be used towards airfare and hotel via Calusa Marketing (valued at up to \$1250) and two (2) tickets to see the Boston Red Sox versus the Baltimore professional baseball team at Camden Yards during the regular season (exact game date to be selected at the sole discretion of Station and/or prize provider). Approximate Retail Value of the grand prize is \$.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Prize or prize certificate must be claimed within thirty (30) days of winning. Failure to claim prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

- a. Up to one (1) winner will be selected at approximately 9:00am ET on April 16, 2019 in a Station-conducted random drawing from all combined eligible online and on-site entries received. Potential winner will be notified by phone and/or email promptly following the random drawing.
- b. Odds of winning depend on the number of combined eligible online and on-site entries received.
- c. Entrants need not listen to the Station or be present to win but must be present at a Station appearance to enter on-site.
- d. If any potential winner(s) cannot be contacted within three (3) business days after being selected as the winner, an alternate winner may be selected (time permitting) in the Station's sole discretion in a random drawing from all remaining combined eligible online and on-site entries received.
