

## 105.7 WROR VACATION A DAY UNIVERSAL ORLANDO RESORT

### OFFICIAL CONTEST RULES

These rules apply to the 105.7 WROR Vacation a Day Universal Orlando Resort Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WROR- FM (“Station”). **In addition, the General Contest Rules posted at wror.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

#### 1.) HOW TO ENTER:

- a) The Contest will begin on Friday, November 1, 2024 and end on Friday, November 22, 2024.
- b) To enter the Contest, entrant may enter via text message or online as follows:
- c) To enter via text message, listen to the Station each weekday beginning on Monday, November 4, 2024 and ending on Friday, November 22, 2024 at approximately 8:20am Eastern Time (“ET”) for the announcement of the artist of the day. Then, between the hours of 8:30am ET and 6:00pm ET, listen for two (2) songs aired back-to-back from that artist. The daily keyword (“Keyword”) will be announced between the airing of the two (2) songs by the daily artist. Each day will have a unique Keyword. Upon the start of the second of the two (2) songs by the daily artist, entrant must text the Keyword to 888-410-1057. Message and data rates may be charged by your wireless carrier. The Station is not responsible for any fees incurred by you for this method of entry. Text message and any mobile device entries will be deemed made by the authorized account holder of the mobile account submitted at the time of entry. The authorized account holder is the natural person who is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. By initiating a text message to the Station in this contest, you also expressly consent to the receipt of a reply message confirming your entry and notification via text if you are selected to be a winner.

Only one (1) entry per person per Keyword is permitted. Multiple entrants are not permitted to share the same telephone number. Entrants are not permitted to use multiple telephone numbers. The deadline to enter each Keyword is ten (10) minutes after the start of the second of the two (2) songs by the daily artist. Any text message entries received ten (10) minutes after the start of the second of the two (2) songs by the daily artist or any text message entries with the incorrect Keyword will be disqualified. Up to one (1) winner will be selected for each Keyword announcement as described below in Section 4.

- d) To enter online, visit [www.wror.com](http://www.wror.com) and follow the links and instructions to complete and submit the online entry form anytime beginning on Friday, November 1, 2024 at 6:00AM Eastern Time (“ET”) and ending on Friday, November 22, 2024 at 10:00AM ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to

the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.

- e) There will be up to a total of sixteen (16) winners selected in the Contest (fifteen (15) winners via the text message method of entry and one (1) online winner). An entrant can only be selected as a winner once in the Contest, regardless of method selected.

## 2.) ELIGIBILITY RESTRICTIONS

- a) This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Massachusetts, New Hampshire or Rhode Island, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

## 3.) PRIZES

- a) Up to sixteen (16) Prizes (each a "Prize") will be awarded. Each Prize Winner ("Winner") will receive a four (4) day, three (3) night trip for Winner and up to one (1) Guest ("Guest") to Universal Orlando Resort ("Universal Orlando") in Orlando, Florida.

Trip will include round trip economy class air transportation for Grand Prize Winner and up to one (1) guest from a major commercial airport (*provided by Spirit Airlines*) near Grand Prize Winner's home (as determined by Universal Orlando in their sole discretion) to Orlando, FL\*; three (3) nights' standard hotel accommodation (one room, double occupancy, room and tax only) at Universal's Cabana Bay Beach Resort or at another Universal Orlando Resort hotel (as determined by Universal Orlando in their sole discretion); non-exclusive ground transportation to and from airport and hotel in Orlando, FL\*; and 3-Park 3-Day Park-to-Park tickets for admission to Universal Studios Florida, Universal Islands of Adventure and Universal Volcano Bay Water Theme Park, for Grand Prize Winner and up to one (1) guest.

The Approximate Retail Value ("ARV") of Orlando Trip is Two Thousand Five Hundred Five and 23/100 Dollars (\$2,505.23).

**Trips must be completed by November 22, 2025 or Prize will be forfeited.** Travel dates and arrangements are subject to air travel, holiday, blackout dates, and other prize and travel restrictions. Travel dates are subject to Universal Orlando and Sponsor approval. Reservations are subject to availability. Trip must be booked at least sixty (60) days prior to intended departure date. If Winner elects to partake in any or all portions of his/her Prize with fewer than the allotted number of Guests or no Guests, the Prize will be awarded to

Winner and each participating Guest and any remainder of the Prize will be forfeited and shall not be subject to further or alternative compensation. All elements of the Prize must be redeemed at the same time, and no changes will be permitted after confirmation of any redemption. If Winner is between the ages of eighteen (18) and twenty-one (21), he/she must be accompanied by an adult of at least twenty-one (21) years of age in order to check into the hotel. Unless child or ward of Winner or one of the allotted Guests, each Guest must be eighteen (18) years of age or older as of the date of departure and must travel on the same itinerary and at the same time as the Winner. ARV of Prize may vary depending upon the points of departure, ground transportation, and/or airline fare fluctuations; any difference between stated ARV and final ARV of Prize will not be awarded. Prize consists only of the elements expressly set forth above; no other elements or expenses (including, without limitation, insurance, meals, unspecified ground transportation, phone calls, baggage, gratuities, incidentals, souvenirs, gasoline, etc.) are included in the Prize and all such expenses are the sole responsibility of Winner. Winner is responsible for any air travel taxes and/or expenses, including applicable departure taxes or fees, inspection charges, baggage fees, and security charges. Winner and Guests are responsible for obtaining, at their own expense, any necessary travel documentation (i.e. valid photo identification, visas, passports, etc.) prior to travel. Once issued, tickets are nontransferable and may not be reissued once travel has commenced. Open tickets may not be issued and stopovers are not permitted. Travel arrangements must be made through Universal Orlando.

In connection with any visit to Universal Orlando, please be advised that Universal Orlando's policies, CDC guidelines, and the recommendations of health officials must be followed. In addition, guests should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before visiting any Universal Orlando destination. **Please note that any public location where people are present provides an inherent risk of exposure to COVID-19, and Universal Orlando cannot guarantee that any person will not be exposed during a visit.**

**Winner will receive from the Station an IRS Form 1099 (or similar) in the amount of the Prize for the 2024 tax year regardless of when Prize trip is taken.**

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the Winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The Winner and Guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the Winner

may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the Winner's stay. Winner and Guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If Winner is unwilling or unable to travel on the dates specified, the Prize will be forfeited and may be awarded to another Winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the Winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If Winner chooses to take the trip without a Guest, s/he will be awarded the prize elements for one person only, and the remainder of the Prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. In addition, Winner and Guest should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before, during and after the trip.

- b) Prizes or prize certificates must be claimed at the office of the Station located at 1075 Main St., Suite 300, Waltham, MA 02451, Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within thirty (30) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the Winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

#### **4.) SELECTION OF WINNERS**

- a) Up to fifteen (15) Winners will be selected via the text message entry method as follows:

Up to one (1) Winner will be selected each weekday beginning on Monday, November 4, 2024 and ending on Friday, November 22, 2024 promptly after the closing of the text entry window in a Station-conducted random drawing from all eligible text entries received for that Keyword. Potential Winner will be notified by phone promptly following the random drawing.

Non-selected entries will not rollover into subsequent text message random drawings, if any.

- b) Up to one (1) additional Winner will be selected at approximately 12:00pm ET on Monday, November 25, 2024 in a Station-conducted random drawing from all eligible online entries received during the Online Entry Period. Potential Winner will be notified by phone and/or email promptly following the random drawing.

- c) Odds of winning via text message depend on the number of eligible text message entries received for each Keyword. Odds of winning online depend on the number of eligible online entries received during the Online Entry Period.
- d) Text message entrants must listen to the Station but do not need to be present to enter or win a Prize. Online entrants need not listen to the Station or be present to win a Prize online.
- e) Winner must confirm acceptance of Prize within five (5) days of winning, or risk disqualification and selection of an alternate Winner (time permitting) in a random drawing of all remaining eligible text message entries from that Keyword's drawing (for an alternate text message winner) and in a random drawing of all remaining eligible online entries (for an alternate online winner).
- f) Decisions of Station management with respect to the Contest are final.

- d) Universal City Development Partners, Ltd. d/b/a Universal Orlando Resort is a prize provider only in this Contest; is not a sponsor of this Contest; and is not responsible for the administration of the Contest, the collection of the entries or the conduct of the draws. Any disputes, claims, and causes of action against Universal Orlando arising out of or relating to any person's use of or participation in any portion of the Prize provided by Universal Orlando shall be resolved by applying the laws of Florida, without regard to conflict of laws provisions therein, and shall be solely and exclusively brought in state or federal courts within Orange County, Florida. Such claims shall be resolved individually, without resort to any form of class action, and all such claims shall be limited to actual out-of-pocket costs incurred, but in no event to include attorneys' fees.
